### Health Law and Privacy and Data Security

She has assisted clients in analyzing and responding to breaches of data and PHI as well as ransomware attacks. She serves as Co-chair of the firm's Privacy and Data Security Practice Group and writes and speaks nationally and internationally on privacy and data security matters affecting medical technology companies.

Elizabeth also advises health care providers, regulated health plans and self-funded employer plans on evolving technologies and new models of health care delivery and payment, including direct employer plan-provider contracting and implementation of Accountable Care Organization (ACO) models. Elizabeth drafted a law creating a statewide integrated population health data system in New Jersey that is available to research applicants. She was appointed to the data system's governing board by the governor as an individual with legal expertise and an interest in protecting the privacy and security of individually identifiable health information. Co-chair of the firm's Government Relations Practice, Elizabeth is known for working closely with members of both political parties and health care leaders throughout New Jersey to improve health care policy. She is also experienced in navigating election law (ELEC) requirements and helping clients avoid "pay to play" and political contributions violations.

Elizabeth is on the committee for *The Garden State FOCUS*, HFMA's bimonthly newsletter circulated to more than 1,200 hospital and health care industry executives and professionals throughout New Jersey. She previously served as editor of the publication. She also took the lead in drafting the HFMA chapter's comments to the Centers for Medicare & Medicaid Services' proposed "meaningful use" comments.

She has been a guest lecturer at Rutgers Law School in Newark, speaking on provider billing and patient payment issues under the ACA.

Elizabeth also serves on the Advisory Board of CareKinesis, Inc., an organization that provides state-of-the-art medication management through a combination of technology, science and services that reduces costs, improves the quality of care and decreases the risks associated with ineffective medication plans.
