Order Regarding Claims Bar Date

Upon consideration of the Motion of Ballamor Golf Holdings, Inc., for an Order pursuant to 11 U.S.C. §§ 105(a), 501, 502, and 1111(a) Rules 2002(a)(7), 3003(c)(3), and 5005(a) of the Federal Rules of Bankruptcy Procedures (i) Establishing Bar Dates For All Creditors to File Proofs of Claim and (ii) Approving Form and Manner of Notice Thereof (the "Motion"); and the Court finding that (i) it has jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334; (ii) this is a core proceeding pursuant to 28 U.S.C. § 157(b)(2); (iii) adequate notice of the Motion has been given under the circumstances and no further notice is required; and (iv) after deliberation and sufficient cause appearing therefore, it is hereby:

ORDERED, that the Motion is GRANTED; and it is further

ORDERED, that January 4, 2010 is established as the General Bar Date, as defined in the Motion; and it is further

ORDERED, that the bar date by which a proof of claim relating to the Debtor's rejection of any executory contract must be filed shall be set in the order approving the rejection of such executory contract; and it is further

ORDERED, that May 20, 2010 is established as the Governmental Unit Claims Bar Date, as defined in the Motion; and it is further

ORDERED that Debtor shall mail the approved *NOTICE OF BAR DATE AND PROCEDURES FOR FILING PROOFS OF CLAIM TO ALL PERSONS ASSERTING A CLAIM AGAINST THE DEBTOR* to the appropriate parties by November 30, 2009; and it is further

ORDERED that the Court, by order entered prior to the General Bar Date, may extend the General Bar Date upon application of any party in interest.
