### **Representative Matters**

Mary's successful litigation results in state and federal court include:

- Denial of plaintiff's petition for review after the Division I Court of Appeals reversed and remanded a previous Superior Court judgment that prevented the collection of certain damages in a personal injury case.
- Judgment in favor of a property manager on a breach of contract claim for more than \$500,000.
- Judgment in a legal malpractice claim involving the distribution of family assets worth more than \$1 million.
- Dismissal of a wrongful termination cause of action.

Mary has also secured numerous summary judgment dismissals, including:
